<b>Teaching and learning support</b>	<ul style="list-style-type: none"> <li>• Teach as a member of a team in a developing capacity mainly within an established programme of study, with the assistance of a mentor if required</li> <li>• May act as a module leader and /or leader of some minor awards (as defined locally with the unions)</li> <li>• Teach in a developing capacity in a variety of settings from small group tutorials to large lectures or the practice environment</li> <li>• Transfer knowledge in the form of practical skills, methods and techniques</li> <li>• Identify learning needs of students and define appropriate learning objectives</li> <li>• Ensure that content, methods of delivery and learning materials will meet the defined learning objectives</li> <li>• Develop own teaching materials, methods and approaches with guidance</li> <li>• Develop the skills of applying appropriate approaches to teaching and practice education</li> <li>• Challenge thinking, foster debate and develop the ability of students to engage in critical discourse and rational thinking</li> <li>• Supervise the work of students, provide advice on study skills and help them with learning problems</li> <li>• Select appropriate assessment instruments and criteria, assess the work and progress of students by reference to the criteria and provide constructive feedback to students</li> <li>• Seek ways of improving performance by reflecting on teaching design and delivery and obtaining and analysing feedback</li> <li>• Undertake examination duties</li> <li>• Participate in course development</li> </ul>
